#### **APPROVAL OF MINUTES:**

Minutes from the May 9, 2023 meeting were approved with one correction on Rachel Richardson's name (Richardson instead of Richards). With that correction, Daniel Shelton initiated the motion for approval and Officer Black followed with a second. The motion carried.

### ANNOUNCEMENTS/INTRODUCTIONS:

Janie introduced the new UAM College of Technology Crossett Vice Chancellor Tracy Tucker who introduced the new UAM-CTC Career Coach, Osmara Mondragon. Other first-time attendees included LuAnne and Freddie Guin, Officer Nicole Carter, Kanesha Wallace, LaTeasha Franklin, and Guest Speaker Agent Territha Reed.

### **PRESENTATION BY AGENT REED:**

Agent Territha Reed, Crisis Intervention Training Coordinator for the Arkansas Commission on Law Enforcement Standards and Training (CLEST) presented information on policies and procedures for referring adults (age 18 and older) to Crisis Stabilization Units (CSUs) in Arkansas. ACT 423, the Criminal Justice Efficiency and Safety Act of 2017, was passed to create behavioral health crisis intervention protocol to implement and fund four CSUs in the State. Currently, the units are 16-bed facilities with two units in northwest Arkansas, one in northeast, and one in Little Rock. Work is in progress to establish a fifth unit in El Dorado.

Individuals can be referred to any of the four units by law enforcement officers, family, friends, the individual in crisis, or anyone concerned about the person in crisis. Priority is given to law enforcement referrals for which purpose the units were created. The units operate on a 24/7 basis, staffed by agencies experienced in providing behavioral health services. Commitment is voluntary and typically encompasses a three-day period of time comprised of initial stabilization, treatment, and possibly prescription of medications. Clients leave the unit with a long-term plan, and the CSU staff provides follow up.

New law enforcement officers (recruits) are required to successfully complete sixteen hours of training related to behavioral health crisis intervention. Veteran officers are required to complete at least eight hours of training to better understand behavioral impairments and mental illnesses. In the training, officers are introduced to mental health professionals, consumers, and family members.

### **REPORT ON PREVENTION CURRICULUM & RESOURCES TEAM:**

Lisa Riels and Liz White reported on the work of the Prevention Curriculum and Resource Teams. Two teachers from each school district comprise the teams: Jessica Griffith and Kelley Allison from Hamburg and Pam Jones and April Adams from Crossett. Each team has a middle and a high school teacher who are experienced in both curriculum development and technology. The development of lessons for this school year are broken into four units of study, each covering a nine-week period. The units follow the data presented by our students both from the Arkansas Prevention Needs Survey and the D-FAC Coalition surveys collected in Spring 2022. According to both sets of data, the primary substance abuse problems are: 1) underage drinking; 2) marijuana; and 3) prescription drugs. The final unit of study will be on mental health issues, suicide prevention, and the negative consequences of substance abuse. A major problem in both school districts is vaping with devices that contain nicotine and possibly THC; consequently, the dangers of this method of consumption will be covered while learning about marijuana. In each district, administrators will determine the protocol for dissemination and frequency of the lessons.
