
This month, keep in mind the following reminders:

 Applications are due June 30, 2023.
- DFC Progress Report The DFC Program is moving into an Annual Progress Reporting cycle. The next report will be due in August 2023 and will cover a reporting period of August 1, 2022, to July 31, 2023. Be sure to check your DFC and CARA Me profiles to ensure that all requirements are met. Data entry can begin now.
