**DELTA UPDATE:** Carolyn Harris, Executive Director Heart2Heart Connections/Mayor of Wilmot talked about their Arts in the Park Event that was partnered with Phoenix Youth and Family Services, Inc., and Summer Camp. Mr. Robert Holt with the Healing Waters Outreach Ministry in Shannon Hills brought supplies to the Heart2Heart Connections Summer Camp including water and breakfast cereal. She expressed sincere appreciation for the contributions and said she was capturing pictures for the Facebook accounts. Mayor Harris and Ms. Evelyn Woods will conduct Naloxone training in Montrose on July 20, from 10-11:30 a.m.





## **HIGH SCHOOL EVENTS:**

- Lisa Riels and Elizabeth White reported that they have met with the two curriculum teams to confirm expectations and plans for next year. The teachers discussed changes, tweaks, and further plans. The unit on underage drinking will be moved to the nine weeks coinciding with prom activities, and the Marijuana/Vaping unit will be moved to the first fall nine weeks. There have been some changes in the consultants for Crossett School District due to workloads, etc. The current consultants are the following: Hamburg Middle School-Kelley Allison; Hamburg High School-Jessica Griffith; Crossett Middle School-Kacy Jo Gill; Crossett High School-Coach Richard Griffith. Riels and White commended the teacher curriculum teams for great work during the school year and summer.
- Lisa will be meeting and working with Hamburg administrators and assisting with the start of the school year. She noted that the drug-free curriculum lessons will begin the second or third week of school.
- Elizabeth has met with Crossett Superintendent Boykin, Principal Adams, and the new high school principal, Bryce Harrison, to confirm dates for the Youth Leadership Group meetings and the curriculum dissemination. There was some thought about designating an office space on one of the campuses for Mrs. White.

## DISCUSSION/RECOMMENDATIONS/SUGGESTIONS:

Faith-Based Sector Leader Ronnie Donaldson gave a presentation: He currently volunteers with Thread of Hope Addiction Ministry that meets every Tuesday at 7 p.m. at South Main Baptist Church in Crossett. He also volunteers for Ashley County Rescue Unit and is an auxiliary policeman. He worked in a prison ministry in Dermott for a year and a half and has done Christian mission work all over the world. One story he shared was about a woman now in successful recovery who has her children back and lives a healthy life in another state. He described how difficult it is for spouses and parents of individuals in addiction and how desperately they need support from caring people (like D-FAC Coalition members). He told us about an inspirational man he works with who was addicted to methamphetamine for 14 years and ended up losing a leg due to his drug use. That man is now instrumental in helping others break free from addiction.

Presentation opportunities are open for September and November.




