# DISCUSSION/RECOMMENDATIONS/SUGGESTIONS:

- 1. MSgt Josh Adams and CW4 Richard Rogers from the Arkansas National Guard Drug Demand Reduction Outreach (DDRO Counterdrug Unit) visited and shared briefly their mission of "reducing substance misuse and its destructive impact on our communities." Information they provided states "Utilizing our unique leadership skills and techniques, we are able to work with coalitions and community base organizations to enable team building, problem solving, and strategic planning. [The] DDRO program provides training and interagency collaboration while advancing prevention efforts across the state." MSgt Adams and Chief Rogers will provide more in-depth information at the November meeting as to their capabilities of assistance to coalitions.

- **3. SPEAKER**: In recognition of the DEA TAKEBACK event on October 26, **Eric Shoffner**, D-FAC Chair and owner/pharmacist of Gammel's Pharmacy in Crossett and ICare Pharmacy in Newport, spoke about the distribution chain of pharmaceutical products from manufacturer to distributor to pharmacy and finally to the consumer. He stated that Law Enforcement is the end recipient of drugs that are reclaimed during TAKEBACK so that the cycle is complete, and drugs do not get reintroduced into society. He explained that the gaps that have occurred in the past are being addressed between now and the end of the calendar year that strengthen the "Track and Trace" capabilities. Bar codes that reveal lot numbers, manufacture date, serial numbers and expiration dates are being applied to all prescription drugs. No longer will facilities be able to "borrow or loan" to other pharmacies even when it would seem harmless to do so. The strengthening of the tracking system is intended to disable illicit exploitation that has occurred.
- **4. DFC Project Director/Vice Chair Mike Neal** informed the group that it appears Treasurer Gina Morgan has moved out of state. He asked for a motion to vacate the position so that the Executive Committee could fill it temporarily until the election in December. Janie Carter made the motion to vacate the position and Eric Shoffner seconded. The motion passed. Mike said that Janie would fill the position temporarily until a new treasurer was elected.
- **5. Harry Hillier** asked that everyone examine the draft copy of the updated Welcome Guide he has been working on.
- **6. Johnny Riley, Jr.,** Regional Prevention Provider and Partnership for Success (Region 3) expressed appreciation for the Coalition and encouraged us to be sure to get our school districts engaged in the Arkansas Prevention Needs Assessment (APNA) Survey. He hopes to attend in person next month.
- 7. **Arthur Johnson** is a Crossett High School and UAM graduate who is educated and experienced in the field of chemical dependency, SUD treatment, Adult and Juvenile Drug Court, and is a radio personality who works actively in community engagement. He is very interested in assisting his hometown of Crossett/Ashley County in our efforts.
