SPEAKER: MSGT Josh Adams from the Arkansas National Guard Counterdrug Unit, Drug Demand Reduction Office (DDRO), made a presentation on the capabilities of his unit. He introduced his colleague, CW3 McMullen who is a pilot with the ARNG. MSgt Adams described the history of and mission/goals of his unit. "The DDRO Program provides training and support in leadership, organizational analysis, planning, decision making, and interagency collaboration while advancing law enforcement community prevention efforts to develop, implement, and evaluate prevention strategies. The DDRO mission focus is to advance prevention efforts to develop, implement, and evaluate prevention strategies for communities they serve. Support key stakeholders in developing and operationalizing substance use and misuse prevention initiatives by utilizing military skill set to promote public health and safety."

DDRO/CO Roles in the Community include the following:

- "Preventing initiation of illicit drug use through education and evidence-based prevention programs.... [using] the Strategic Prevention Framework (SPF) process [as provided by the Community Anti-Drug Coalitions of America (CADCA)].
- Strategic planning, motivating and creating teams for a common goal.
- Our presence in communities enhances community relations, ethics/moral character, and confidence within the scope of the field.
- Our profession instills trust and confidence with schools, communities, coalitions and local leaders by demonstrating character, competence and commitment.
- Media Support; social media, videos, commercials, advertisements (through collaboration with National Guard Public Affairs
 Office)
- Facilitating, coaching, and evaluating current coalition meetings and processes.
- Community support with town hall events, community events, school events, camps, youth engagements.
- Delivering curriculum in school-based settings and trainings.
- Data workgroup and analysis at the Federal, State, and local level.
- Collaboration across all sectors, force multiplying, recruiting, and capacity building.
- Grant Writing and Resources.
- Panelist for drug forums."

D-FAC members were very receptive of the presentation and information and look forward to future partnerships regarding potential block parties and a mobile "classroom" being created to educate parents about keeping drugs and paraphernalia out of their homes. Mandy Morris asked if MSgt Adams can assist D-FAC in processing a new youth survey this year, and he assured her that he and his civilian operations analyst will gladly do so.

1 TYPES OF MEMBERSHIP

ACTIVE: Must be a resident of or employed in Ashley County, Arkansas, attend a minimum of six [6] monthly meetings and be actively involved in the work of the Coalition. Active members have voting rights that can be revoked if attendance falls below required threshold.

SUPPORTING: May not be able to attend all meetings regularly but is familiar with the work of the Coalition, supports prevention efforts and has a vested personal or professional interest in the community. Supporting members have no voting rights; however, if their meeting attendance reaches a total of three [3], they have one vote.

EXTENDED: Not necessarily aware of the day-to-day work of the Coalition but is an individual or community leader who may be contacted occasionally regarding specific prevention issues and or specific tasks.

Our 5-year grant has the possibility of being extended to a maximum of ten years. The match for the first six years is at 100%. One thing that is very important is attendance. Every volunteer event, everyone in attendance, including youth and volunteers, is a "good in-kind match".
