JANUARY 28, 2025

The second annual D-FAC Youth Summit will be held at the Hamburg First Baptist Church ROC Activities Building. Coordinators are planning the event based on requests from the students and with follow-up from Robert Holt, the Youth Consultant who has been working with the Coalition over the past two years.

Coordinators are working with the student youth groups on the Johnny's Ambassador project for peer-led presentations about the dangers of today's marijuana. More information will be shared as the project develops.

DISCUSSION/RECOMMENDATIONS/SUGGESTIONS:

Vice Chair & Project Director Mike Neal gave an overview of by-law changes being discussed by the D-FAC officers. The exact wording of the changes will be sent to the members at least two weeks prior to the February meeting. The changes are in regards to changing the levels of members to only two: "Active" and "Supporting" by combining some of the description of the existing level of "Extended" and incorporating that into the "Supporting" level. Another projected change is to combine the positions of Secretary and Treasurer into one position and rather than being an elected position, it would be one appointed by the Executive Committee. Clarification of the makeup of the Executive Committee and the voting rights of those members will be addressed. Voting on the by-laws will be done at the February meeting by members who are eligible to vote. Members who have attended at least three meetings are eligible to vote one time.

PROGRAM: Hamburg Police Chief Johnny Oliver addressed the members and stated that Ashley County does have bad drug problems. He said we know that Fentanyl is deadly and now there is one "out there" that is even worse. He said that the Coalition is needed and that it does take all of us (the village) to keep our kids and citizens safe. He stressed that enforcing the law is the primary role of law enforcement but that they also need to be compassionate and that we need to start educating our children at a younger age than ever before. Chief Oliver said that the School Resource Officers (SRO's) are important in educating, enforcing, and building healthy relationships with our youth.

He introduced Officer Brandon Kelley who made an excellent presentation. Officer Kelley said that vapes are the number one problem in the schools and that vapes are being confiscated that contain THC, but that even vaping nicotine in high concentrations can cause seizures. His PowerPoint presentation is attached to the minutes. He answered questions and gave statistics and examples of why we should be concerned and continue to work together to prevent drug and alcohol use among our youth. He stated that he is the person who teaches the Drug-Free curriculum developed through the efforts of the Coalition to eighth graders in Hamburg and that he feels it is very good information. Lisa Riels commented that the SRO's in both Hamburg and Crossett have been great to work with us.

The Juvenile Drug Court Coordinator, Vivian Guimbellot made two comments in the Chat Box:

- 1. "THC vapes are out of control. We have 12 kids with drug court and other programs that are addicted to those THC vapes.
- 2. They have websites you can order vapes from and have them mailed to your home with no verification of age needed."

Chairman Eric Shoffner commented that hallucinogens are now life-threatening. The concentrations that were available in earlier years have totally changed.

Janie Carter commented on the work done by Arlyn Richards in keeping the website interesting and informative. She noted that Arlyn has recently done some editing and rearranging of categories and information. She encouraged members to stay informed regularly with what is being posted.
