✓ MSGT Joshua Adams announced that the DEA has determined their Spring 2025 TAKEBACK Day to be Saturday, April 26. He informed Chief Oliver that pickup of returned medications should be conducted during the week (or so) following that event.

✓ By-law changes being discussed by the D-FAC officers will be sent to the members at least two weeks prior to the March meeting. The changes are regarding changing the levels of members to only two: "Active" and "Supporting" by combining some of the description

of the existing level of "Extended" and incorporating that into the "Supporting" level. Another projected change is to combine the positions of Secretary and Treasurer into one position and rather than being an elected position, it would be one appointed by the Executive Committee. Clarification of the makeup of the Executive Committee and the voting rights of those members will be addressed. Voting on the by-laws will be done at the March meeting by members who are eligible to vote. Members who have attended at least three meetings are eligible to vote one time.

Mike stated that he was working with the Crossett Youth Center Board and MSGT Adams for a future county-wide block party event and for a possible new sector leader for youth-serving organizations.

PROGRAM

Dr. Lula Williams and her staff presented the program explaining the "Let's Talk Offline" Workshops sponsored by the Family Development Enterprise, Inc. Dr. Williams is a dental surgeon, originally from Pine Bluff, AR, who now lives in Northeast Louisiana. Her initiative is a community-based organization that provides workshops for youth ages 10-19 to empower them in positive life skills, decision-making skills, and all aspects of life. Her curriculum and methods are scientific and evidence-based. The workshop facilitators are certified to address the needs of youth by tailoring delivery appropriately by age group. Parents can participate in the workshops that are delivered either virtually or in person. She stated that there is a parent component that includes the needs of teen mothers. She commented that she can empathize and relate to young people through her personal life experiences. She described a few of the workshops that are available, stating that the "Love Notes Program" is a 13-module workshop that, when completed, will qualify participants to receive a \$75 incentive. Other workshops include "Rights of Passage," "Healthy Relationships," "The Chemistry of Attraction," "Financial Literacy," and several others.

The program director, Gaynelle Raybon, told members that parental permission is required, and that the structure of the workshops provides

students with a success sequence and an abundance of resources. One of the facilitators, Ivory Collins, enthusiastically talked about how she strives to make the workshops fun for participants and said something she values is the discussions on expectations in relationships. A minimum of 10 participants are required to conduct a workshop, and Kanesha Wallace in Hamburg is the Professional Development Coordinator who is working with Ms. Raybon and Dr. Williams to set up workshops in Ashley County. In Kind Contributions: Coalition members were reminded to report in-kind service hours and donations to Janie Carter, Interim Treasurer.
